

RESOLUTION 2022-21

RESOLUTION ESTABLISHING PRECINCTS AND POLLING PLACES

WHEREAS, the legislature of the State of Minnesota has been redistricted; and

WHEREAS, Minnesota Statutes Section 204B.14, Subdivision 3(d) requires that precinct boundaries must be reestablished within 60 days of when the legislature has been redistricted or at least 19 weeks before the State Primary Election, whichever comes first.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Little Falls, Morrison County, Minnesota, has determined that the boundaries of the voting precincts and polling places as follows and adopted in Ordinance No. 29, Seventh Series:

- First Ward/Precinct (Initiative Foundation, 405 Southeast First Street): The First Ward shall consist of the area within the City limits of the City of Little Falls commencing at the easterly shoreline of the Mississippi River northerly of the centerline of Trunk Highway 27/Broadway Avenue East to the southerly centerline of Fourth Avenue Northeast, and the easterly centerline of First Street East lying easterly of the easterly shoreline of the Mississippi River and lying southerly of the centerline of Fourth Street Northeast and the area lying easterly of the centerline of US Highway 10/371 to the easterly City limits and the area southerly from the centerline of Morrison County Road 43 to the southerly City limits of the City of Little Falls.
- Second Ward/Precinct (City Hall, 100 Northeast Seventh Avenue): The Second Ward shall consist of the area within the City limits of the City of Little Falls commencing at the easterly shoreline of the Mississippi River from Fourth Avenue Northeast to the northerly City limits and the area northerly of the centerline line of Morrison County Road 43 to the northerly City limits of the City of Little Falls.
- Third Ward/Precinct (Bethel Lutheran Church, 901 West Broadway): The Third Ward shall consist of the area within the City limits of the City of Little Falls commencing at the westerly shoreline of the Mississippi River westerly of the centerline of First Street East and area southerly of the centerline of Trunk Highway 27/Broadway Avenue East to the southerly City limits of the City of Little Falls.


BE IT FURTHER RESOLVED, For illustrative purposes, a map showing said ward/precincts is hereby included.

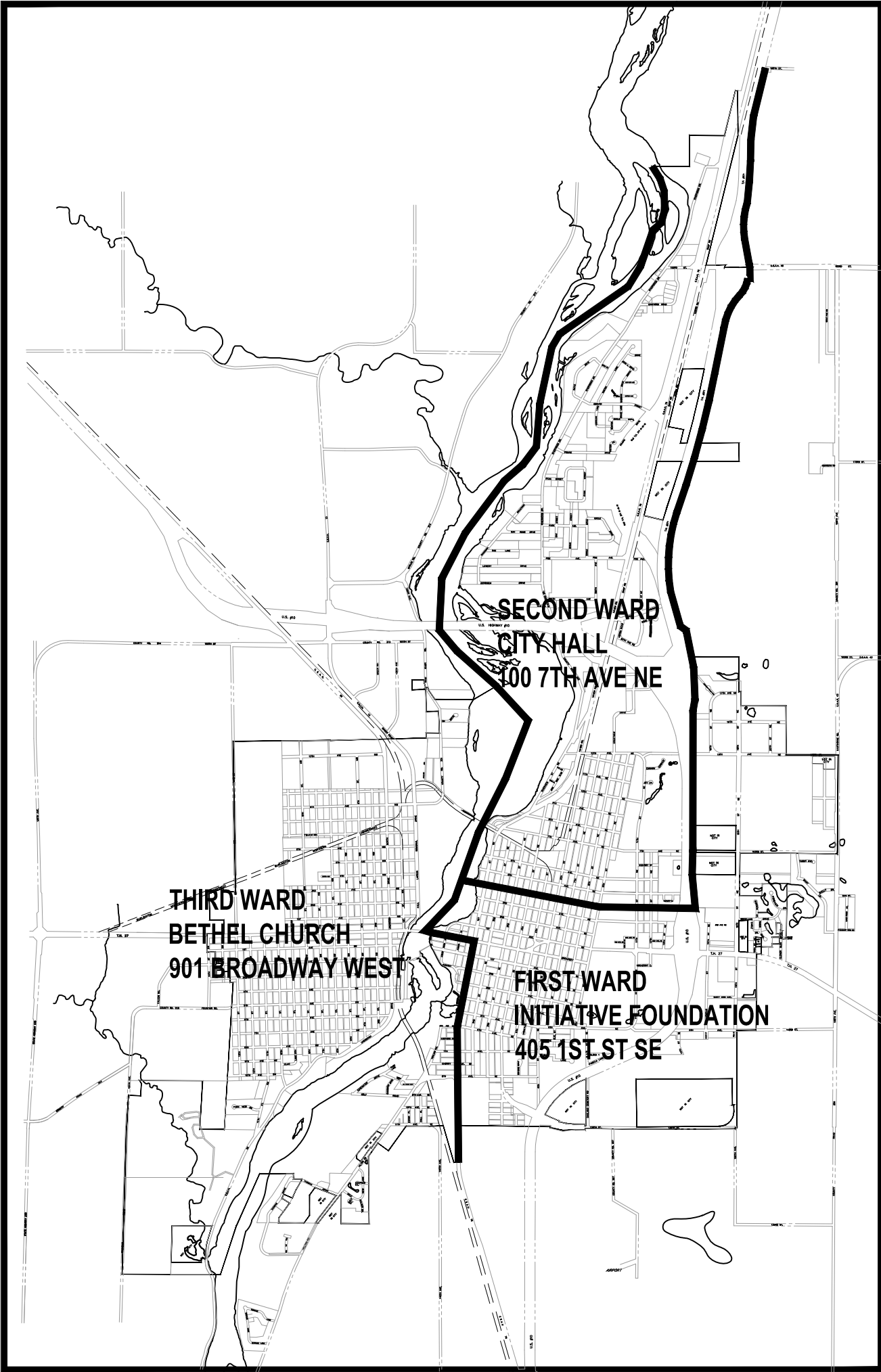
